Pursuant to Regulation 30 of Listing Regulations, it is informed that the Company is in receipt of email dated December 13, 2024 from BSE and NSE each for imposing the fine of Rs. 5000/- (excluding GST) for delay in compliance of Regulation 23 (9) of SEBI (LODR) Regulations, 2015 pertaining to delay in filing disclosure of related party transactions on consolidated basis for the quarter and half year ending September 30, 2024 by 1 day.

The Company has informed the Stock Exchanges that while we made attempt to submit the disclosure of related party transactions on time, technical issues caused a delay of 6 minutes in submitting to the NSE. Additionally, we faced uploading difficulties that prevented us from submitting to the BSE at that time. Once the issue was resolved, we ensured that the documents were submitted to BSE on the following day.

The fine levied by NSE and BSE has no impact on the financial, operation or other activities of the Bank.

The Company wish to also clarify that there was neither any malafide intention nor any loss to stakeholders.
