In accordance with the provisions of Regulation 30 read with Para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, it is informed that CELM Logistics SA de CV, Mexico, a step-down wholly owned overseas subsidiary of Allcargo Logistics Limited, has been voluntarily liquidated with effect from December 12, 2024 and the company received the official communication from the authorities of Mexico on December 31, 2024.

Consequently, CELM Logistics SA de CV, Mexico has ceased to be a step-down wholly owned overseas subsidiary of the Company.
