**Subject: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 - Approval for Strike off of Altcargo Oil & Gas Private Limited, Subsidiary**

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform you that Altcargo Oil & Gas Private Limited ("**AOGPL**") had filed an application for striking off its name from the record of Register of Companies, Mumbai under sub section (5) of Section 248 of the Companies Act, 2013 and rule 9 of the Companies (Removal of Names of Companies from the Register of Companies) Rules, 2016.

Based on aforementioned application of AOGPL, the Ministry of Corporate Affairs ("**MCA**") has struck off the name of AOGPL from the records of Registrar of Companies and the said Company is dissolved w.e.f. March 11, 2024.

Consequently, AOGPL has ceased to exist as a company and as such as a subsidiary of the Company.
