

## Allcargo International Supply Chain (ISC) Monthly Operational Update

### FCL operations:

- Allcargo registered its highest ever monthly FCL volume during the month of December 2024. FCL Volume stood at 59,566 TEUs. This represents a growth of 13% as compared to the last year and 14% as compared to previous month.
- Volume for the calendar year ended December 2024 stood at 6,46,090 TEUs, which is the highest ever yearly volume. This represents a growth of 9% over 2023.
- FCL volume witnessed growth across LATAM, India, USA, Canada and Indian Subcontinent and remained flat in Asia Pacific and Europe.




### Air operations:


- Air volume for the month of December 2024 stood at 2,864'000 kilos. This represents a growth of 42% as compared to the last year and 2% as compared to previous month.
- Volume for the calendar year ended December 2024 stood at 30.4 million kilos, which is the highest ever yearly volume. This represents a growth of 28% over 2023.
- Air volume witnessed month on month growth across Canada, India, Latin America and Europe.

### LCL operations:

- LCL volume stood at 735'000 cubic meters for the month of December 2024 as compared to 728'000 cubic meters in December 2023, depicting a growth of 1%. The volumes have grown 2% as compared to last month.
- For the calendar year ended December 2024, LCL volume stood at 8.9 million cubic meters depicting a growth of 2% over 2023.
- Demand remained healthy on account of the early Lunar New Year and anticipation of US trade tariffs, thus supporting the freight rates, which remained range bound.
- LCL volume witnessed month on month growth in Asia Pacific, India and Indian Subcontinent and remained flat in Middle East and Latin America.




**Container utilization:** Container utilization remained flat as compared to 12 months ago.

**40 feet ratio:** 40 feet container usage improved as compared to last month, which is in line with the volumes. However, it remained 4% higher over 12 months ago.
